



# Office of Labor Standards Enforcements (OLSE) **Certified Payroll, Prevailing Wages, LCP Tracker Training**

#### Labor Standards Fact Sheet

Information and requirements for contractors and subcontractors bidding on public works contracts in the City and County of San Francisco:

- Pay workers the correct prevailing wage rates for each craft, classification and type of Work performed. SF Administrative Code 6.22(e)(1); CA State Labor Code Section 1773 and 1774
- Submit certified payroll reports and fringe benefit statements into the City's electronic payroll reporting system (LCPtracker). SF Administrative Code 6.22(e)(6); CA State LC Section 1776
- Maintain Office of Labor Standards Enforcement (OLSE) daily sign in sheets documenting all hours worked and the classifications of work performed. SF Administrative Code 6.22(e)(7)(C)
- Display OLSE provided posters at the jobsite, informing workers of Prevailing Wage requirements. SF Administrative Code 6.22(e)(7)(D)
- Furnish employees with itemized pay stubs and retain payroll records. CA State Labor Code Section 226
- Employ apprentices registered in a state-approved apprenticeship program and make apprenticeship training contributions. CA State Labor Code Section 1777.5
- Register with the California Department of Industrial Relations (DIR). CA State Labor Code Section 1725.5
- Comply with local labor laws including the Minimum Compensation Ordinance, Health Care Accountability Ordinance, Health Care Security Ordinance, Fair Chance Ordinance and miscellaneous Prevailing Wage Ordinances where applicable. SF Administrative Code Ch. 14, 12P, 12Q, 12T and 21C

# Office of Economic & Workforce Development (OEWD) **30% Local Hiring Policy, 50% Local Apprentices**

- San Francisco Administrative Code Chapter 6.22(G)  $\bullet$
- Local Hiring Requirements (Section 00 73 30)  ${\color{black}\bullet}$ 
  - 30% of total work hours, by trade, must be performed by San Francisco residents
  - Where apprentices are utilized, 50% of total apprentice hours, by trade, must be performed by San Francisco residents
- The City will not issue NTP until Contractor completes and submits the following:
  - Form 1: Local Hiring Workforce Projection
  - Form 2: Local Hiring Plan


# Contract Management Division (CMD) **Policies and Requirements**

- LBE Subcontracting Goal: 20%  $\bullet$ 
  - Only LBE contractors certified by the SF Contract Monitoring Division are eligible to meet that goal.
  - Form 2B "Good Faith Outreach" is required to be submitted with Bid.
- LBE Subcontracting Goal:
  - To meet the LBE % goal, search for City of San Francisco LBE Certified Firms on the CMD website page:
    - GoTo: <u>http://mission.sfgov/hrc\_certification/search.aspx</u>
    - Scroll down to "General & Special Construction Contractors" to find trades and click on the trade you are searching for, then scroll down to bottom of page and "click here to search by criteria".
    - On the Directory of Certified Firms page, click "All Vendors" at the top of the page to find City of San Francisco Micro LBE Certified Firms to meet the Micro LBE % requirement.
  - If the general contractor's or prime contractor's firm is a certified LBE, then a 10% bid discount is applied at the bid, but the general or prime's certification as an LBE does not apply to the LBE % goal. The prime must still meet LBE % goal with subcontractors chosen from the City's LBE Certified Firms.



# **Project Information**



- Submittal Phase LDs of \$200/ day if submittals are more than 21 days from NTP.
- Purpose: To insure earliest possible procurement and delivery of (2) gensets amid supply chain issues
- Notice of Award initiates the execution of Contract Agreement
  - To be on time, strongly suggested to use the time between the executed Contract Agreement and the NTP date to work with your subcontractors, particularly the electrical sub, to be on time

- Work related to abatement must be performed by a contractor licensed in the removal of hazmat materials
- On the Bid Form:
  - Bids will be broken down by lump sum per Fire Station in the bid form
  - The allowance for <u>unforeseen</u> hazardous materials will be a credit change order back to the City if unused.
    - The allowance is not used for in contract abatement work referred to in the contract documents and outlined in bid section 01 35 50 for above ground tank system closure requirements
  - Partnering Requirements: The partnering allowance of \$5000 will be used by the GC for meetings between the Owner, the Contractor and the City's facilitator with the goal of conflict resolution- see Section 01 31 33.
- There are 3 LDs in contract that the City will enforce see bid section 00 73 02:
  - Submittals are due 21 days from NTP or LDs of \$200 per day apply
  - Substantial Completion LDs \$2500 per day
  - Final Completion LDs \$500 per day

# **Bid Information**

- This work is taking place in (2) 24/7 continuously occupied and busy fire stations:
  - GC's Regular Work Hours: 8:30 am to 5:30. The 830 start is due to the shift change that takes place between 730 to 830 which is the station's busiest time of day
- Total contract time from NTP to Substantial Completion is 455 days
- Permits that need to be obtained by General Contractor
  - The contractor is responsible for obtaining the fuel piping permit from DBI and must submit signed and sealed engineering plans for review, approval and permit (initially to the City then) to DBI • The contractor provides all SFMTA related permits for temp parking, traffic control and street lane closures
- Permits obtained by the City
  - The BAAQMD Authority to Construct permits have been obtained by the city and are based on a specific engine manufacturer and model.

Diesel Internal Combustion Engine, Stationary, Emergency Standby 131 BHP Iveco/ FPT 2018

- Should the contractor propose an engine that is not on the permit, the contractor will be entirely responsible for cost, time and effort for the new BAAQMD permit.
- The generators are permitted within the permit plans; GHD engineer Chris Richards will discuss further.
  - Any contractor changes to the permitted plans will need to be submitted to DBI by the contractor

## **Bid Information**

Fire Station 37 – Remove existing generator with belly tank, concrete pad, automatic transfer switch and all associated equipment. Install new concrete pad with belly tank, new diesel generator, automatic transfer switch, new in-ground fuel fill station, and all associated equipment.

Fire Station 44 – Remove existing generator with belly tank, concrete pad, automatic transfer switch and all associated equipment. Install new concrete pad with belly tank, new diesel generator, automatic transfer switch, new remote fuel fill station, and all associated equipment.

#### For both Fire Station 37 and Fire Station 44:

- Remove and replace wood fence.
- Provide temporary diesel generator and fuel as required to provide continuous backup power for entire project duration.
- Provide diesel fuel to completely fill new belly tank.
- Provide new conduit, cabling, signage, new penetrations in existing assemblies and all other work as shown on the drawings and specifications.
