The Scope of Work: This project involves mechanical, electrical, and plumbing improvements to the Homeless Shelter located at 1001 Polk Street in San Francisco. The mechanical and plumbing improvements include selective demolition and replacement HVAC mechanical systems including new fans and VAV boxes controlled by CO2 sensors, design and replacement of the pneumatic controls with direct digital controls, and replacement of boiler. The scope of work also includes demolition and replacement of rooftop fan penthouse walls and roof; minor structural repair of the structural slab under the Geary, Polk, and Cedar Street sidewalks; and electrical service and lighting improvements. The Homeless Shelter will be occupied and open during construction.

The time allowed for completion is 385 consecutive calendar days. The estimated construction cost is approximately \$2,271,000. For more information, contact the Project Manager Sherry Katz by phone: (415) 654-0651 or email: Sherry.Katz@sfdpw.org.

On July 1, 2014, the registration program under section 1725.5 of the California Labor Code went into effect. Pursuant to San Francisco Administrative Code ("Administrative Code") Section 6.25 and Chapter 25 of the Environment Code, "Clean Construction" is required for the performance of all work.

This Contract is subject to the requirements of Administrative Code Chapter 12X, which prohibits contracting in states with laws that allow discrimination. The City is prohibited from entering into any Contract with a Contractor that has its United States headquarters in a state on the Covered State List or where any or all of the work on the contract will be performed in any of those states on the Covered State List.
